Rules & Regulations

Definitions. Capitalized terms used herein, but not defined herein shall have the meaning defined in the Agency Agreement or the applicable Commission Schedule(s).

Wholesale Agency: Refers to a biBerk wholesale partner with a valid Agency Agreement.

Agency Agreement: Shall mean the valid, executed contract between biBerk and Wholesale Agency.

biBerk: Shall mean biBerk Insurance Services, Inc. on behalf of itself and its insurance affiliates.

Incentive: Shall mean the program described herein.

Incentive Period: Shall mean February 1, 2026 to April 30, 2026 at 11:59 PM CST. biBerk is not responsible for late or incomplete sales.

New Business: Shall mean a policy sold during the Incentive Period which is otherwise eligible for commission under the applicable Commission Schedule within the Agency Agreement, and which remains in effect for at least thirty (30) days after the policy effective date.

Principal: Shall mean the primary business operator(s) of the Wholesale Agency previously registered with biBerk as the Wholesale Agency Principal.

Producer: Refers to independent subproducers working with biBerk Wholesale Agency partners.

This incentive is sponsored by biBerk. The Incentive is open to Agency Principals and Producers only. For a Principal or Producer to be eligible to receive a payout, their Agency must remain active and in good standing at all times relevant hereto, as determined by biBerk. Brokers are not eligible to participate in the Incentive. This Incentive is void where prohibited.

Incentive Payouts: Principals or Producers will earn an Incentive Payout of Twenty-Five dollars (\$25.00) for every New Business policy they sell during the Incentive Period.

Principals or Producers awarded monthly at the time commissions are paid depending on your Wholesaler Agency. If a policy on which an Incentive Payout was paid does not remain in effect for at least thirty days after the policy effective date, or otherwise becomes ineligible for a New Business commission under the terms of the Agency Agreement, then Principal or Producer shall be obligated to refund the Incentive Payout paid thereon to biBerk.

Principal and Producers may be issued a 1099 in connection with Incentive Payouts. Taxes (if any) are the sole responsibility of Principal or Producer.

General Conditions. All federal, state and local laws apply. By participating, Wholesaler Agency, Principals and Producers agree: (a) to be bound by these rules and regulations and by the decisions of biBerk, which shall be final in all respects, and waive any right to claim ambiguity in the Incentive or these rules and regulations; (b) to the use of their names, voices and/or likeness by biBerk on the biBerk Gateway or for advertising and publicity purposes via any medium, all without compensation; and (c) to release, discharge and hold harmless biBerk, its affiliated companies, producers, parents, subsidiaries, and its and their respective officers, directors, employees, and representatives from all claims or damages arising out of their participation in the Incentive.
